## THE NEW YORK BAR FOUNDATION AWARDS \$392,500 IN CHARITABLE AND EDUCATIONAL GRANTS

Sixty-seven grants were presented across New York state totaling \$392,500, from this year's grant cycle.

"The Foundation's grant program assists non-profit organizations with the front-page issues of our communities. The need for funding for law-related projects continues to grow," said Bar Foundation President Cristine Cioffi (Cioffi • Slezak • Wildgrube). "The Foundation is pleased to provide financial support that will benefit children and adults throughout New York state, but there is much more that can be done."

Foundation grants support programs that provide legal services to children in foster care, domestic abuse survivors, immigrants, the elderly and veterans. Their legal matters include guardianships, bankruptcy, foreclosures, elder abuse, debt collection and consumer debt. Additionally, The Foundation presented residual funds from Superstorm Sandy relief efforts totaling \$2,500 to meet remaining law-related needs due to the storm. The Foundation previously awarded \$52,000 in grants to 13 organizations.

Funding for the grants comes from contributions to The Foundation by lawyers, law firms, corporations and others. One hundred percent of their donations are awarded to beneficiary organizations.

"The collective impact of the Foundation's donors complements the efforts of local organizations by providing representation of underserved, vulnerable people in need, and support for legal education that might otherwise not be available," said Lucia B. Whisenand, chair of The Foundation's Grant Committee.
